# 16c Special-Delivery Air-Mail

Imperfurate—Ungummed  
Authorized first day of sale March 15,  
1935, at Washington, D. C.  
Issued during the administration of  
Franklin D. Roosevelt  
President of the United States  
and under the authority of  
James A. Farley  
Postmaster General

On this cover is one of 28 different stamps, similar to those from the specimen sheets of stamps which were issued during the period from March 4, 1933, to October 8, 1934, and privately distributed. The specimen stamps differed from the regularly issued stamps of this period because they were ungummed and, in all but two instances, were imperfurate. The specimen stamps were not available to the general public and this created such a protest from Philatelists that the Post Office Department has issued similar stamps to prevent a future fictitious value on the original issue.

Stamps issued imperfurate are: 3c MOTHER'S DAY; 3c WISCONSIN; 16c SPECIAL DELIVERY-AIR MAIL; 1c to 10c NATIONAL PARK SERIES; Souvenir Sheets of the 1c and 3c CENTURY OF PROGRESS; 1c and 3c NATIONAL PARKS; 3c LITTLE AMERICA. The 3c NEWBURGH and the 3c LITTLE AMERICA are issued in perforated form.


